Scope: Conus Firearms Shop – MSM & GMs

The vendor has communicated to HQ that Smith & Wesson has identified two M&P Shield EZ Pistols on which the hammers manufactured by the supplier were cracked. In those firearms, the hammer failed to fully engage the sear, causing the round to fire, cycling the slide, and potentially resulting in multiple discharges without depressing the trigger.

Description: This notice applies ONLY to M&P® Shield[™] EZ pistols (including Performance Center® models) manufactured between March 1, 2020 and October 31, 2020, and only to a small percentage of that population. It does NOT apply to all SHIELD[™] pistols. To determine whether your M&P Shield EZ Pistol is affected, check the label on the box to determine the date of manufacture. If the date is between March 1, 2020 and October 31, 2020 – your pistol may be affected. After inspection, if the hammer from your firearm is affected, it will be replaced at no cost to you. We expect that this entire process will take no longer, than 10 business days, and your pistol will be returned as quickly and efficiently as possible. All shipping and replacement costs will be covered by Smith & Wesson.
