

18-024 QA PRODUCT RECALL – PEPPERIDGE FARMS GOLDFISH DUE TO SALMONELLA HAZARD

Scope: Select Exchange Retail Stores and Distribution Centers

Pepperidge Farms in cooperation with the Food and Drug Administration has announced a recall of certain varieties of Goldfish Crackers.

Hazard: One of the ingredient suppliers that supplies whey powder, a seasoning that is applied to four varieties of crackers has been the subject of a recall due to the potential presence of *Salmonella*.

Description: This recall involves four varieties of Goldfish Crackers which came in different packaging options. These are as follows: Flavor Blasted® Xtra Cheddar, Flavor Blasted® Sour Cream & Onion, Goldfish® Baked with Whole Grain Xtra Cheddar, Goldfish® Mix Xtra Cheddar + Pretzel. A list of the affected items with the associated codes are shown in the table below. The Exchange only sold the items noted with the astrisk (*).
