

Brick 10000185: Cigarettes

Definition

Includes any products that can be described/observed as a cylindrical roll of finely cut, cured tobacco, or a blend of tobacco and herbs, designed to be smoked.

Notably smaller than most cigars and always wrapped in thin paper, usually white.

These products may or may not have a filter, can be flavoured with products such as Menthol.

Excludes products such as vapour Electronic Cigarettes, Herbal Cigarettes – Non Tobacco, Cigars, Cigarettes, Cigarette Filters, Cigarette Papers and Rolling Tobacco.

Tobacco Products/Smoking Accessories Variety Packs

Definition
